- A. (1) PAN CARD as issued by the Income Tax Authority.  
(2) Valid 15 digit Goods and Services Taxpayer Identification Number (GSTIN)

- B. Credential Certificate of successful completion of similar nature of work along with the work order for works completed within last three years of values not less than 50% (fifty percent) of the work applied for including mentioning time of completion of the work.  
All intending applicants should see the detailed NIQ in the office of the Registrar of the University.
- C. When the applicant is an authorized signatory, he should submit documents of authorization in his favour with the application.
- D. In case of Partnership Firms, they should submit copy of "Partnership Deed" with their application. Otherwise, application will not be entertained.
